

## Meeting Minutes East Contra Costa County IRWM Region Meeting Wednesday – September 25, 2019, 10:00 to 11:30 a.m. Action Items in Bold

- 1) Welcome and Introductions

- 2) Approve Previous Meeting Minutes
  - The meeting minutes from the 8/14/19 meeting will be proposed for approval at the next IRWM meeting.
- 3) Update on Existing Grants
  - Prop 1 DAC Involvement Grant Program, San Joaquin River Funding Area Woodard & Curran are continuing to work on the San Joaquin River Funding Area Needs Assessment. A draft is expected in early October once the final two regional outreach meetings are completed.
  - b. Prop 1 DAC Involvement Grant Program, San Francisco Bay Area Funding Area
    - CCC Resource Conservation District has now completed 5 listening sessions in Bay Point, Pittsburg, and Antioch; a total of nine sessions are planned to be completed.
    - DWR and SFEP executed their funding agreement for the DACI program. CCC RCD and SFEP are finalizing their agreement now, and it is close to being completed.
    - CCC RCD expects to develop a report to summarize the results of the listening sessions. They hope that the sessions will provide input on priorities of the community.
- 4) Prop 1 Implementation Round 1
  - The group reviewed the proposed projects for changes with respect to DWR's comments at the 8/28 workshop. CCWD described that they have been working with DWR to try to resolve some critical comments for the Bethel Island Consolidation project for Beacon West and Willows Mobile Home Park, but with limited success. It seems that CCWD will not be able to resolve the issues with DWR prior to the due dates for this grant round.
  - The group discussed options for the proposal and funding requests, if CCWD were to remove the project from the proposal. Below is a table summarizing the project costs and grant requests.

• Part of the discussion included what to do with the "additional funds" listed in the table above, which were allocated to the projects several months ago in an attempt to consolidate available implementation funding into a single round/grant agreement. The group's intent was to revisit these allocations prior to finalizing the proposal to determine if adjustments are needed based on the draft Needs Assessment report that was anticipated in August.

- Woodard & Curran have since modified their production schedule to show that the draft Needs Assessment report will be available in early October. Therefore, the report will not be available for review prior to finalizing the funding requests.
- Mr. Samuelson suggested that the additional funds be left allocated as they are, and that the Project 5 funding shown in the table above (\$448,335) be saved for CCWD for Round 2. CCWD confirmed support of this suggestion, clarifying that CCWD would attempt to use the funding for a Bethel Island consolidation project in Round 2, if possible. All participants at the meeting were in favor of this plan of action; there were no objections.
- The group reviewed the Final Grant Application checklist prepared by Ms. Duckler, including a detailed discussion about Attachments 1 through 7. The group reviewed the proposed schedule on the back of the agenda for due dates. The Local Project Sponsors (LPSs) will take responsibility for copying/pasting the PIF information into the updated PIF form. Ms. Duckler will send the updated form to the group for use.
- The group discussed the eligibility criteria required as a part of Attachment 1. Ms. Dutton will reach out to DWR for clarification on the Groundwater Management Plan self-certification reporting requirements, and inquire about the threshold for what constitutes a project that "directly" impacts groundwater.
