2) Approve Previous Meeting Minutes

• The meeting minutes from the 8/14/19 and 9/25/19 meetings were provided to the group for review prior to the meeting. Mr. Muelrath motioned to approve the minutes and Mr. Amirzehni provided the second motion. No objections; the meeting minutes were approved.

3) Update on Existing Grants

- a. Prop 1 DAC Involvement Grant Program, San Joaquin River Funding Area
 - Woodard & Curran completed the San Joaquin River Funding Area (SJRFA) Draft Needs Assessment. The draft was distributed to the group on 10/22/2019. Comments on the draft are due 11/8/2019.
 - A conference call with the SJRFA representatives was held on 10/16/2019; notes from the call are attached. Slides from the conference call describing the Draft Needs Assessment are also attached.
- b. Prop 1 DAC Involvement Grant Program, San Francisco Bay Area Funding Area
 - CCC Resource Conservation District (CCC RCD) held a kickoff meeting with MTC in early October to kickoff the sub-agreement. CCC RCD is finishing up its listening sessions and anticipates completing their needs assessment in December 2019 or January 2020. CCC RCD is conducting an online survey that will be used for the needs assessment as well.

4) Agency Adoption of East Contra Costa County IRWM Plan 2019 Update

- Agencies can now adopt the East County IRWM Plan 2019 Update. Adoption is required by all local project sponsors in the Prop 1 Implementation Round 1 application prior to executing an agreement for the funding with DWR.

 - The application for this grant is due 11/15/2019. The group reviewed the grant application checklist to discuss outstanding items. The group reviewed the deliverable schedule on the back of the meeting's agenda. The group concurred with this schedule.
